On the grounds stated in the accompanying statement of claim, the Applicant claims:

1. Declarations that the First Respondent and Second Respondent have contravened sections 45, 90 and 323 of the *Fair Work Act 2009* (Cth) (**FW Act**) as set out in the statement of claim.
2. A declaration that the Second Respondent has contravened section 535 of the FW Act as set out in the statement of claim.
3. An order for compensation pursuant to section 545 of the FW Act for loss suffered by the Applicant and each Group Member in connection with the contraventions of the FW Act as set out in the statement of claim.
4. An order for interest on such amounts of compensation pursuant to section 547 of the FW Act.
5. An order for payment of a pecuniary penalty pursuant to section 546 of the FW Act, to be paid to the Applicant and each Group Member as set out in the statement of claim.
6. Such further order as the Court sees fit, including as to costs.

Questions common to claims of group members

The questions of law or fact common to the claims of the Group Members are detailed in paragraph 118 of the statement of claim.
