#### THE STELLAR CLASS ACTION

# Tania Kelehear v Stellar Personnel Brisbane Pty Limited and Stellar Recruitment Pty Ltd (VID 1662/2018)

#### **OPT OUT AND REGISTRATION NOTICE**

#### This Notice is important. It relates to your right to:

- (a) opt out of this class action if you do not wish to be part of it; or
- (b) register your claim as part of this class action to facilitate the prospect of a settlement being reached at the pending Court-ordered mediation; or
- (c) do nothing.

#### **SECTION 1 – INFORMATION ABOUT THE CLASS ACTION**

- 1. According to the records of Stellar Personnel Brisbane Pty Limited or Stellar Recruitment Pty Limited (both referred to as **Stellar** in this notice) you are or were an employee of Stellar.
- 2. As an employee or former employee of Stellar your legal rights may be affected by a class action brought against Stellar in the Federal Court of Australia (the **Court**), by Ms Tania Kelehear, a former Stellar production employee, brought on her own behalf and on behalf of all other persons (**Group Members**) who:
  - (a) were employed by Stellar at any time between 25 December 2012 and 24 December 2018;
  - (b) were employed as a production and engineering employee within the meaning of Schedule A of the *Black Coal Mining Industry Award 2010*; and
  - (c) who were treated as a "casual" employee by Stellar.

The class action seeks orders from the Court awarding compensation and imposing penalties upon Stellar for asserted underpayments of annual leave to Ms Kelehear and the Group Members. The law firm, Adero Law, acts on behalf of Ms Kelehear in the class action.

3. The allegations made by Ms Kelehear against Stellar are set out in the Amended Statement of Claim, a copy of which is available at: <u>https://www.aderolaw.com.au/class-actions/mining/stellar</u>. Stellar is defending the class action and a copy of its Defence is also available at that link.



- 4. On 2 October 2023, the Court made orders referring the class action to a mediation to be conducted by a Registrar of the Court (**Mediation**). On 5 December 2023 the Court also made orders:
  - (a) requiring that any Group Member that wishes to opt out of the class action must do so by 4:00 pm on 29 February 2024 (the Opt Out Deadline); and
  - (b) informing Group Members that they may register their interest in making a claim through the class action by 4:00 pm on 29 February 2024 (**the Registration Deadline**).
- 5. The Court directed that this Notice be sent to all Group Members in the class action so that they are aware of their options.

# **SECTION 2 – YOUR OPTIONS**

- 6. **You have three options:** 
  - **Option 1: Opt Out of the Stellar Class Action by the Opt Out Deadline**
  - Option 2: Register your interest in making a claim through the Stellar Class Action by the Registration Deadline
  - **Option 3:** Do nothing

Each option has different consequences, which are explained below. You should carefully read the information about your options.

## **OPTION 1: OPT OUT**

- If you wish to opt out of the class action, you must complete the Opt Out Notice attached at Schedule A to this notice and send it to the Court by the Opt Out Deadline at 4:00 pm on 29 February 2024, either by:
  - (a) **email to:** <u>vicreg@fedcourt.gov.au</u>, with the email subject line: "Opt Out Notice VID1662/2018"; or
  - (b) post to: Federal Court of Australia, Victoria Registry, 305 William Street, Melbourne, VIC, 3000.



8. <u>If you opt out of the class action, you will no longer be a Group Member and will no longer</u> <u>be a part of the class action.</u> This means you will not be affected by any orders made in the class action; you will not be bound by any settlement or judgment in the class action and you will be able to commence separate proceedings against Stellar on your own behalf if you so wish. It also means that you will not be entitled to receive any benefit or compensation arising from any favourable judgment or settlement that may be obtained in the class action.

# OPTION 2: REGISTER YOUR INTEREST IN MAKING A CLAIM THROUGH THE STELLAR CLASS ACTION

- 9. If you wish to register your interest in making a claim through the Stellar Class Action you must complete the Registration Form attached at Schedule B to this notice and send it to Adero Law by the Registration Deadline at 4:00 pm on 29 February 2024, either by:
  - (a) **email to:** <u>stellaraction@aderolaw.com.au;</u> or
  - (b) **post to:** Adero Law, 3 Hobart Place, Canberra ACT 2601
- 10. Registering for the Stellar Class Action involves providing details about you and your claim to Adero Law. This allows Adero Law to better take your claim into account at the pending Court ordered mediation and any subsequent settlement discussions. It will also mean that Adero Law has your contact details, which will facilitate the distribution of further notices to you in the future with information about the progress of the class action (including in relation to any settlement, or after any judgment following the trial of common issues).
- 11. You do not have to register to remain a Group Member, and subject to any further order, as a Group Member you will be entitled to share in the benefit of any settlement that is obtained at the pending mediation or in any subsequent settlement discussions. However, Adero Law has told the Court that if Group Members register their claims the firm will be in a better position to take those claims into account at the pending mediation, and that registration will facilitate settlement by allowing the parties to reach a more informed view about the overall value of Group Members' claims.
- 12. It is likely that at some point you will need to register your interest to participate anyway either to get money in any settlement or, if there is no settlement, to take further steps to bring your claim forward following the initial trial of the issues that are common as between Ms Kelehear's claim and any claim you may have (**common issues**).



- 13. Further, and importantly, if a settlement is reached in the mediation, or at any point before the trial commences, Adero Law has informed the Court that <u>Ms Kelehear intends to apply for an order that any Group Member who did not register prior to the Registration Deadline will remain a Group Member and be bound by any settlement of the proceeding, but will not be entitled to any share of any monetary compensation that is gained from the settlement. It will be a matter for the Court hearing the settlement approval application to decide whether making such an order would be fair and just.</u>
- You can register for the Stellar Class Action by completing the Stellar Class Action registration form at <a href="https://www.aderolaw.com.au/class-actions/mining/stellar/">https://www.aderolaw.com.au/class-actions/mining/stellar/</a> by 4:00 pm on 29 February 2024 or by completing the hard copy registration form attached at Schedule B to this Notice and returning that hard copy form to Adero Law before 4:00 pm on 29 February 2024 at the addresses noted at paragraph 9 above.

#### **OPTION 3: DO NOTHING**

- 15. If you do not opt out of or register for the Stellar Class Action (and you have not already registered with or signed a retainer agreement with Adero Law), you will remain a Group Member and, subject to any further order, you will be entitled to share in the benefit of any settlement that is obtained at the pending mediation or in any subsequent settlement discussions.
- 16. However, as stated above, if a settlement is reached in the Mediation, or at any point before the trial commences, Adero Law has informed the Court that <u>Ms Kelehear intends to apply for</u> an order that any Group Member who did not register prior to the Registration Deadline will remain a Group Member and be bound by any settlement of the proceeding, but will not be entitled to any share of any monetary compensation that is gained from the settlement. It will be a matter for the Court hearing the settlement approval application to decide whether making such an order would be fair and just.
- 17. Further, as stated above, it is likely that at some point you will need to register your interest to participate anyway either to get money in any settlement or, if there is no settlement, to take further steps to bring your claim forward following the trial of the common issues.



# WILL GROUP MEMBERS BE LIABLE FOR LEGAL COSTS IF THEY REMAIN PART OF THE CLASS ACTION?

- 18. Adero Law is conducting the class action on a "no win, no fee" basis, and in the event that the class action is <u>unsuccessful</u>, Group Members will have no liability to pay any legal costs or any litigation funding charges.
- 19. In the event that the class action is <u>successful</u> (that is, if money compensation is recovered), the Court will be asked to make orders for the legal costs to be deducted from the money recovered, so that the burden of the legal costs is shared fairly among the persons who stand to benefit from the class action. The effect of any such order, if made, would be that all Group Members who benefit from the proceeding will contribute to the legal costs on a pro rata basis, from their share of the settlement money. Before any legal costs can be deducted the Court must approve the costs as being fair, reasonable and proportionate and Group Members will be entitled to object in relation to that.
